#### Top Issues of Concern from Your Neighbors

Noted by volunteers last fall \*Parking, especially on the street. Larger vehicles and those parked close to corners were particularly noticed as problematic \*Trash and trash cans visible from the street \*Shrubbery too close to corners obstructing sight lines for vehicles

\*Items stored outside, visible from the front \*Dead trees and plants

\*Siding repairs, cleaning, gutters, and paint touchups needed

\*Holiday and other outside lights being left on display after the holiday is over
