Parking tickets and traffic safety

Test your knowledge: true or false?

1. It is legal to park on the left side of a residential street during daylight hours.

2. You can get a ticket for parking in front of a person's mailbox.

3. It is legal to bike on the left side of the street (facing traffic.)

4. It is safer to walk in the same direction as traffic (on the right side of the street) if there are no sidewalks.

5. You can park 10 feet from a fire hydrant.

6. It is legal to park within 2 car lengths of an intersection in the state of Georgia. *(Answers on the back)*

Answers to Traffic Quiz:

1. False. You must park on the right side (with your car facing the same way as the moving traffic on that side) of any 2-way street regardless of time of day. You can be ticketed if you don't.

2. False. You probably will not get a ticket, but the person with the blocked mailbox may not get their mail. Rural mail carriers are not required to get out of their vehicles to deliver mail, though they often do it anyway.

3. False. Bikers must ride to the right, with traffic. People aged 16 and under must wear helmets. Above age 16, you may elect not to wear helmets-unless you think maybe there is something in your head worth protecting!

4. False. Pedestrians should walk to the left (unless they are on a sidewalk), so that they face oncoming traffic closest to them. This allows them to move off the roadway if the oncoming car does not yield. Although the law requires that drivers yield to walkers, this is small consolation when a pedestrian is hit. Important point: people walking are rarely as visible to drivers as they think.

5. False. You may only park 15 feet or further from fire hydrants.

6. False (depending on the length of the car, of course). You must park at least 30 feet from intersections. Keep in mind that in some situations, 30 feet may not be enough for safety—especially if traffic in the cross street moves quickly, like at our subdivision entrance.
