

May '05 General Meeting: We would like to thank those neighbors who came to the May 9<sup>th</sup> General Meeting and helped make it a great success. A quorum was easily reached at this year's General Meeting, and as a result we accomplished many things which the outgoing board and officers have been working on. **Privacy Policy approved:** Our privacy policy regarding the use of email in the Association's business, drafted and approved by the outgoing Board and President, was also approved at the May Meeting. This policy formalizes the practices that have been in use since 2002. It summarizes the official privacy policy in relationship to membership email addresses remaining private and only used for DHOA Board purposes; also, how official email and personal information is used. The policy was approved unanimously.

Parking and Safety: The DHOA Board has continued to hear many complaints regarding parking. Commercial or large vehicles cannot be parked on the street for more than one hour. It is a violation of our covenants and county ordinances. Members at the meeting expressed concern over speeding in the neighborhood as well as parking hazards to drivers.

**Timber Glen membership grows:** Mrs. Kirchoffer expressed interest in serving as Timber Glen liaison to the Board and block captain to Timber Glen but wanted more specifics on what the duties of this position would entail. Some Timber Glen members were told that they have covenants of their own and are consulting with Sherry Hoger on ways to determine this. Sherry was the driving force behind DHOA's recent Covenant renewal with Gwinnett County.

Hwy 78 Revitalization project: Sherry Hoger has offered to try and organize a meeting with our County Commissioner to come to our neighborhood this summer to discuss the project with us and give us opportunity to voice our concerns. She would also like to elicit the County's assistance to enforce parking violations.
