## Loose dogs? Call 770-513-5700, even nights & W/Es

Did you know you can now call for an Animal Control Officer any day of the week and even after hours? The Gwinnett Police Non-Emergency number, also called the Police Dispatch Office or Communications Office, is the first and main contact, at **770.513.5700**.

In the past few months, there have been several reports of loose dogs coming into people's yards. Residents have posted comments on our DHOA FaceBook page, and others have visited dog owners to tell them of the problems their dogs are causing when they get out.

If you see loose dogs and don't feel comfortable checking for tags (or if they have none, which has been the situation recently), get a couple of pictures and print them out to share with the officer in case the dogs are gone by the time the officer arrives. The officer who responds to your call will conduct a brief investigation (here's where your pics come in handy) and take your statement.

If you have problems with dogs or this procedure, please send a comment to the DHOA FaceBook page to let others know what happened, and what has been done.

But if you happen to call the Gwinnett Animal Control rather than the nonemergency dispatch number, you're now given the option to be transferred to the right number to reach an officer.

#### **Dog Bites Get Priority**

If you have a dog bite that needs emergency attention, call 911. But if you don't need emergency care, just call the non-emergency number above to get an officer out and report the problem.

## **Curbside Recycling Changes July 1: No more glass**

As of July 1, Waste Pro will no longer collect glass. Glass now joins a number of other items that are recyclable but that aren't accepted at curbside, like plastic bags, Styrofoam, and rechargeable batteries. If these items are placed in recycle bins, they are put in landfills rather than being recycled.

## Curbside Recycling: Waste Pro Misses Recycling Days

by Patricia Yeargin Waste Pro has missed picking up our recycling on Tuesday a few times in the past 6 months.

Calling the County to report the most recent event (June 4), I learned that Waste Pro can be fined for missing pickup days. This happens in 2 cases: if the same household reports a problem 3 times within 6 months, or if Waste Pro misses a whole neighborhood -- and 5 or more people must report the missed pickups.

What you can do: If Waste Pro misses us on Tuesday, report it ASAP (Wednesday morning is best): 770.822.7141, M-F 8-5.

Now for some good news: The monthly fee for solid waste collection is being reduced, and the senior discount for those 62 and older will increase on July 1<sup>st</sup>. Note that you'll have to apply for this discount in writing after July 1<sup>st</sup>. For more info, visit www.gcsolidwaste.com or call the Gwinnett Solid Waste Center at 770.822.7141 M-F from 8 am to 5 pm.

Haulers will also supply covered, wheeled 65-gallon recycle carts, but Waste Pro says you have to request one after August 1<sup>st</sup>. Call them at 770.451.9395.

## Yards, storms, & falling trees

June came in with a bang--thunder, high winds, hail, falling trees & branches. The National Weather Service classified our June 1<sup>st</sup> afternoon storm as a "downburst" with winds measured up to 85-90 mph, which is equivalent to an F1 tornado.

People are still cleaning up, but this is a good time to look at the trees on your property to see if any are unhealthy (dead branches or leaves), or threatening (broken branches, leaning over your house or your neighbor's). If you're not sure, get an expert -- a "tree surgeon" who will figure out if you can safely save your trees. Visit <u>https://georgiaarborist.org/</u> to find someone who can come out and assess your trees and tell you how to manage or mitigate any threat.

It's best to look at trees now, while you're out there cleaning up the yard after our long winter and soggy spring. Don't wait till something falls and you have to deal with the insurance company!

## Outdoor Fires Banned May 1 – September 30

Gwinnett County bans outdoor burning for the whole summer. Call 678.518.4979 for more or visit <u>www.gwinnettfiremarshal.com</u> to learn about restrictions and safe burning practices. After September 30, burning is only banned on high fire-risk days. But even on low fire-risk days, the County has specific safety requirements that must be met.

If you suspect someone is violating the ban or is burning unsafely, you can report it at 770.513.5700, or after hours call 911.
