# **Summary of the General Meeting on May 13**

The general meeting on May 13 resulted in the election of a new board and an approved budget for the upcoming year. There were 43 paid households requiring a 20% quorum of 9. There were eleven households attending the meeting and one proxy held by an attending household.

After all outstanding payments, our balance was \$6948.65 plus one additional uncashed dues check (\$60) as reported by the treasurer. As usual, the HOA's biggest expense was \$3452.42 to maintain the front landscaping, including this year lighting repair replacement (thanks and Jacobson) James and new plantings. Additionally this year our electric bill increased from 12.13 to 15.90 monthly. The membership donated \$255 to our firehouse local and board members John, Blake, and Roger donated an additional \$45 to provide one \$100 Publix gift



card for each of the three shifts, delivered by the Parkman household on May 12 (photo).

The membership approved a budget of \$4961. This includes a budget of \$400 for a new neighborhood directory and \$750 for events. Several members noted the addition of new children recently and discussed organizing an event with child-friendly activities (bouncy house, bean bag throw) possibly on the day of the fall yard sale in October.

The membership elected the following officers: Patricia Yeargin as President, Nicole Wright as Vice President, James Jacobson as Treasurer, Claire Gloeckner as Secretary, and John Dyer and Blake Parkman as board members.

# No Parking on the Street

Please remember that our covenants don't allow street parking other than for very brief periods of time. We've heard numerous complaints lately, and given the poor visibility on our curvy and hilly streets, coupled with lack of sidewalks, school kids, and bus stops, it's just not safe. Please park in your garage.

#### Test your knowledge: true or false?

- 1. It is legal to park on the left side of a residential street during daylight hours.
- 2. You can get a ticket for parking in front of a person's mailbox.
- 3. It is legal to bike on the left side of the street (facing traffic.)
- 4. It is safer to walk in the same direction as traffic (on the right side of the street) if there are no sidewalks.
- 5. You can park 10 feet from a fire hydrant.
- 6. It is legal to park within 2 car lengths of an intersection in the state of Georgia.

# **Lilburn Farmers Market!**

Starting June 7, the Lilburn Farmer's Market at Good Shepherd Presbyterian across Killian Hill is once again open each Friday afternoon. It is open from 4 pm to 8 pm each Friday through August.. It's a great treat for all of us living in Deerbrook because we can walk to the market! Police officers are there until about 6:30 to help us across Killian Hill. At the market you can get fresh, local, and organic produce, and other goods, and support the local community.

#### Answers to Traffic Quiz:

- **1. False.** You must park on the right side (with your car facing the same way as the moving traffic on that side) of any 2-way street regardless of time of day. You can be ticketed if you don't.
- 2. False. You probably will not get a ticket, but the person with the blocked mailbox may not get their mail. Rural mail carriers are not required to get out of their vehicles to deliver mail, though they often do it anyway.
- **3. False.** Bikers must ride to the right, with traffic. People aged 16 and under must wear helmets. Above age 16, you may elect not to wear helmets--unless you think maybe there is something in your head worth protecting!
- 4. False. Pedestrians should walk to the left (unless they are on a sidewalk), so that they face oncoming traffic closest to them. This allows them to move off the roadway if the oncoming car does not yield. Although the law requires that drivers yield to walkers, this is small consolation when a pedestrian is hit. Important point: people walking are rarely as visible to drivers as they think.
- **5. False.** You may only park 15 feet or further from fire hydrants.
- **6. False** (depending on the length of the car, of course). You must park at least 30 feet from intersections. Keep in mind that in some situations, 30 feet may not be enough for safety—especially if traffic in the cross street moves quickly, like at our subdivision entrance.
