Submit Questions for the Information Meeting August 22: Sherry Hoger has organized an informational meeting which has been set for August 22nd to be held at her house on 1391 Doe Hollow Trace. Gwinnett County 3rd District Commissioner Mike Beaudreau will start the event off as the featured speaker at 7:00pm. Connie Lawson, Real Estate Agent with REMAX,

will also speak at 7:30pm. Mr. Beaudreau will address specific questions which Sherry plans to give them before the event. There will be some time for discussion, but we want to have all the important questions given to the Commissioner prior to his visit so that he can have the answers ready. Ms. Lawson will be addressing how to improve the values of homes in Deerbrook, and how to bring up neighborhood "comps" so that, when we do move, we can get better prices for our houses. Questions that have been submitted so far:

- When will the widening of Killian Hill take place, and will it will affect traffic flow and our entrance?
- How the new school on Killian Hill will affect traffic;
- How the County can help us on street parking, given that wrecks are the fault of drivers who must leave their lanes;
- When the Spikes restaurant site will be cleaned up;
- Who is responsible for overgrown weeds at the ditch at Hasty Acres and Five Forks Trickum; and
- Information on the US 78 improvement project and where to find public notification of future changes

Outdoor Fire Ban: A reminder to all residents there is a Gwinnett County

outdoor fire ban in effect from May 1st through September 30th. Violations are punishable by \$500 fines and/or jail time. To report a violation of the fire ban call 770-513-5100; if no answer, call 770-513-5911.

Posting of Signs: Just a reminder that posting signs on County right-of-way property (at front entry) is against County Ordinance. Weekend signs for open houses are allowed, but must be removed by Sunday night. Official DHOA activity signs are allowed on a short-term basis.

The planting cost less than \$120.00 thanks to all the volunteer work.

October Meeting and Oktoberfest: The Board agreed to hold both an Oktoberfest celebration and general membership meeting the same day on Saturday the 15th of October in the Rustlewood cul de sac. There will be the party from 3:30pm until

about 5pm when the meeting will be held. The Board will organize and provide supervision of children in designated play area while parents can attend a quick 20-minute meeting and vote on any pending issues. Patricia can refer volunteers to the board member or coordinator of specific tasks or items.

Directories to be published: The new DHOA member Directories are almost ready for printing and binding. Patricia Yeargin plans to coordinate a gathering with several other members to complete the process of putting the pages into the comb binding with distribution to follow soon after. Households (including associate members) who have paid dues for 2005 get one free copy of the directory.

Dues: If you have not paid your dues for 2005, it's not too late. Please drop your check for \$40.00 payable to DHOA to Brian mailbox, located at 4163 Swinkola's Deerbrook. For \$40.00 DHOA members are getting a great deal. Most associations cost over \$100 a year on average and typically are mandatory. Houses located in HOA neighborhoods also typically sell for a bit more than similar houses not in HOA neighborhoods. Our voluntary dues take care of the lighting and landscaping of the front entrance, printing of our DHOA directory, newsletters, special event flyers, and also towards record keeping with the County as well as events like our Oktoberfest and the General Meetings in May and October.

Home Service Referrals Needed.

If you have had work done on your home (either exterior or interior) and are happy with the bonded company that did the work, please let us know. We would like to be able to recommend those companies to other neighbors who may be looking for someone to work around their home.

Parking and Safety: The DHOA Board has hear continued to many complaints regarding parking. Please be courteous to your neighbors by not parking in front of their home for extended lengths of time or blocking mailboxes. Commercial or large vehicles cannot be parked on the street for more than one hour. It is a violation of our covenants and county ordinances. Members are encouraged by the Board to report violations of Gwinnett code to the County. Pets and Other Peoples' Yards: Both the County and DHOA Covenants require that pets be fenced, on leash, or otherwise restrained when outside. Both also mandate that pet droppings be cleaned up by the pet owner. We've noticed that most people take baggies with them for this purpose, which is most appreciated, but have had several complaints about brown spots left on lawns due to unsupervised pets--mainly dogs. If you've let your pet into someone else's yard, please pick up after it. If you see dogs or other pets running loose, you can call Gwinnett Animal Control at 770 339-3200.

Crime Watch: Recently two of our neighbor's cars were vandalized. One had a piece of cinder block thrown through the windshield while it was parked on the street at night, and the other got a good sized This occurred on Deerbrook Way near Wheatley. While crime is relatively low in our neighborhood, it's always good to keep an eye out when you hear or see anything unusual. Call 911 if you see any suspicious activities, and let one of the Board members know so that we can keep everyone up to date. Just for the record, we've not heard recently of any more "garage snatchings" where lawn equipment was stolen. More people are keeping their garages locked up, though.

Any Timber Glen resident who turned in a Household Information form a few months ago will also be listed in the DHOA Directory.
