Now let's talk trash!

Houses that look bad: In general, the homes look good in Deerbrook,

but one or two neglected ones can make us all look bad. There have been concerns about eyesores and control out of grass in neighborhood. This hurts the sales and sale prices of homes in the Deerbrook, which are already down due to the economy. This eventually hurts all of us, because just about everyone will someday sell their You houses. can help neighbors and yourself by keeping your home looking good.

No more loose bags of trash: With the new trash arrangement, we can recycle so many more types of plastic, paper, and cardboard. That's

good, because we can no longer have garbage. ΑII extra the household trash must fit into your 95gallon trash container; if it doesn't, Waste Pro is not required to pick it up. In fact, if you have too much trash to fit, you have to get a second container from Waste Pro for a \$20 delivery fee. Then you get to pay an extra \$12 per month for trash pickup. If you have a 65-gallon container far (which SO haven't been delivered). and can't fit vou everything into it, we're told you'll have to trade up to the 95-gallon one.

Recycling made easy: If you have too much recycling to fit into your container, you have 3 options: you can buy a recycling bin; you can request a second recycling bin from Waste Pro for a one-time delivery charge of \$15; or you can use any container marked "Recycling".

Large trash items: Waste Pro will also pick up furniture and most large items, but you have to schedule them 48 hours before the regular trash pickup day. They will only pick up refrigerators and freezers that have been tagged after the Freon has been properly removed. And they won't pick up car batteries.

Yard waste pickup is an optional service that is not included in the county-wide plan. If you want this service, you must contact your hauler directly. Cost is \$60 for 6 months of pickup. Or, you can find an inconspicuous spot in your backyard to compost yard waste.

Reach a local Waste Pro staffer: The main number on the trash cans reaches a call center in Illinois, which doesn't have access to your account information. They are able to communicate your information to the local Waste Pro via computer. But if you want to reach someone who knows what's going on in Gwinnett, call 770.777.1447.

Opt out of ads on your mailbox & driveway. Did you know you can legally opt out of the handbills, business cards, and paper ads that seem to show up constantly on your mailbox and driveway?

Under Gwinnett code, these paper ads are not allowed if you post a special green "no handbills" decal on your mailbox. You can order a decal online. Go to www.gwinnettcb.org, then choose "Litter prevention."

From that web page you can read about handbills and litter, or go to the online order form. It's the handbill equivalent of the 'do not call' list – it won't stop everyone from leaving stuff, but anything that is put on your mailbox or in your driveway after that can be reported.
