## **Deerbrook Priority Survey Results**

Responses to the Priority Survey made one thing clear: keeping the front entrance looking good is very important. Average rankings are noted below:

Several people added concerns and suggestions on their survey responses which deserve follow-up. For instance:

Like DHOA residents, the Board also takes its duty regarding advising residents of **covenant violations** very seriously. We get calls from concerned

residents and give reminder notices to violators. Most people cooperate when asked to comply with the covenants.

Street parking was another concern raised by respondents. Parking on the hilly, tree-lined, twisty streets of Deerbrook is not safe. Our covenants allow residential street parking for periods of less than 24 hours, but we request that all park off the street whenever possible.

Another suggestion was to hike annual dues to improve the front entrance. We have made improvements to the front in the last year and will continue to do so, but we can discuss dues changes and more at the 10/6 meeting.

# **Fall Meeting Plans & Discussion**

The Fall business meeting will start at about 2:15 on Sunday, Oct. 6th, after everyone gets a chance to get something to eat & drink. We will start with planning our December dues drive and holiday activities.

The following suggestions from the Priority Survey will be discussed at the October 6 meeting:

- Speeding near the entrance, on Deerbrook & on Fawnbrook
- Look into deceleration lane on Killian Hill, a right turn lane coming into Deerbrook Way to cut down on illegal passing on Killian Hill and to allow drivers to slow down before entering Deerbrook.
- Getting our own neighborhood on Nextdoor rather than being part of Lucerne/Oleander

There are several options for dealing with speeders within Deerbrook, from speedbumps to extra police patrols, stop signs, yard signs, and more. We've started talking with the County about some of these options already and would love to hear what you think.

Some respondents asked for more enforcement of covenants, assessing penalties for those who don't comply with covenants, and citing people who don't take care of their yards. DHOA does have legal remedies that can be pursued, but they tend to be costly. We can discuss this at the meeting too.

Some other suggestions from surveys that we might want to discuss include:

- How people with big harvests from vegetable gardens can share with neighbors
- Participating in Yellow River cleanup
- 3. Setting up pollinator gardens
- 4. Soccer in the cul-de-sacs
- 5. Preserving our tree canopy
- Mosquito control that doesn't kill bees & butterflies
- 7. Ask Walton EMC to evaluate streetlights to meet higher standards

Please come, bring the kids, bring a chair, and let's work on making Deerbrook the best it can be.
