New State Rules on Building Contractors. For those who are planning to hire a general contractor, there is now more consumer protection. As of July 2008, most general contractors are required to meet certain standards and be licensed by the state. This gives

consumers a way to make complaints, and it gives the state tools to discipline contractors if needed. The state of Georgia asked the DHOA to help spread the word, so we've attached their notification letter to this newsletter.
