**Luminaria Night and Cookie Swap** Sunday December 11: At the October general meeting, members voted to put out luminaries again this year. You can pick up luminary supplies Saturday, December 10, 1 to 5 pm on Rustlewood Court. If you want to swap cookies, bring some by on Sunday afternoon the 11th between 3 p.m. to 5 p.m. to trade. *Please bring a bucket for sand!* You can bring your dues as well (see below), and a luminary supply charge of \$5. You may write a single check for \$45 to DHOA for dues and luminary supplies. Luminaries are placed at every other seam or break in the concrete on the curbs, and lit at dusk. **DHOA Membership Dues:** Dues for 2006 are payable in December. Pay when you pick up your luminaries or drop them off in the mailbox of the Treasurer, Brian Swinkola at 4163 Deerbrook Way. Our dues are very low currently at \$40.00 per year. Deerbrook expects a major expense as we will need to replace the sign in the front entrance soon. It is over 20 years old and is starting to show its age. The sign has been repaired once, 3 years ago. We hope to collect 100% of dues this year to begin saving for the new sign. And if you have ideas for fundraisers, let us know.

Other General Meeting Actions: The HOA members present voted to put out Luminaries again this year. After some discussion, Sunday, December 11th was selected, with a backup date of the 18th—remembering how the wind blew down our candles last year. Mark Ackerman, a former DHOA President & longtime resident, has agreed to start up a Garden club. He will get a sign for 'Yard of the Month' sign made and is looking for members to
