## Keep Streets, Gutters & Storm Drains Clear

Deerbrook has serious rains and flooding from time to time, and our street-side gutters route the water off the roads and into drains. Keeping them clear to get water off our roads is critical to safety and security in our neighborhood during serious weather conditions.

Per Gwinnett County Code, homeowners (or renters) are responsible for keeping the streets, gutters and drains clear of debris like leaves, pine needles and mulch in front of their property.

If you hire a contracted lawn service, please make sure that they blow debris off the gutters and streets, but NOT into the storm drain. And if there is a storm drain on your property, be sure they clear it too.

If you see any drainage problem, it can be reported to Gwinnett County Stormwater Maintenance Customer Service Center at 678.376.7000.

### **Front Entrance Lighting Upgrade**

In May's general meeting budget was approved for an electrical facelift for the front entrance. This summer the Board approved a plan to replace the old flood lamps on the ground that light up the sign from below. Some wiring needed to be made safer and up to code as well. Previous safety omissions from the original developer were also corrected. James Jacobson was the volunteer Board member who got it done for us. Now we are shining brighter thanks to James' help!

Just a reminder: DHOA covenants require trash cans and recycling bins to be "decoratively hidden so as not to be visible from the street or adjoining lots except on trash day.
