Commissioners approve millage rate increase: The Gwinnett County Board of Commissioners adopted the 2009 millage rate and approved a resolution to levy taxes during a special called meeting on December 1, 2009. The new millage rate of 13.25 mills is an increase of 2.28 mills over the 2008 property tax rate. Three funds are affected by the increase: the General Fund (+2.06 mils), the Recreation Fund (+0.21 mils), and the General Obligation Bond fund (+0.01 mils). The property tax increase will allow County government to restore some key services that were cut earlier this year, stabilizing specific services such as police, fire, sheriff, courts. libraries. parks and transportation (mowing rights of way) and keeping the correctional facility open.

When will the reconciled tax bill be sent and when will payment be due? Property owners were billed in August 2009 for 2009 property taxes based on a temporary millage rate of 10.97 (equal to the 2008 millage rate). The temporary and final 2009 millage rates will be reconciled and a second round of 2009 tax bills for the additional amount will be mailed to property owners sometime during the first half of 2010. Payment will be due in one installment 60 days from the billing date. It should be noted that the Gwinnett County Board of Commissioners will adopt a 2010 millage rate that will result in a separate 2010 property tax billing later in the year.

What does this mean for property owners? The majority of homeowners those whose homes are valued at \$200,000 or less - will see an increase of less than \$14 per month. The increase for 50 percent of all business owners - those with commercial property values of less than \$500,000 - will be \$38 a month or less.

What will the millage increase fund? The following items will be funded:

- Elected and constitutional officials will be restored to their March 3, 2009, budgeted levels, which includes:
 - Process improvements
 - 287g program
- Fire and Emergency Services
 - Station 18 relocation
 - \circ Station 29 to open
 - Station 30 to open
- Police
 - 58 uniform patrol package added
 - Quality of Life Unit reestablished
 - Some vehicle replacements
 - Radio system maintenance
- Libraries
 - All 14 existing branches will remain open with equal hours of service
 - 15th library, Hamilton Mill Branch, will open at same service level as the other branches
 - Postpone regional library plan
- Corrections
 - Comprehensive Correctional Facility to remain open at March 3, 2009 operational levels
- Transportation
 - Restore frequency of rights-of-way mowing
- Subsidies
 - Restore subsidies with the exception of the Latin American Association
 - Association of Retarded Citizens

- o Barrier Free Gwinnett
- Board of Health
- o Children's Shelter
- Council for Seniors
- DFACS
- GRN Community Service Board
- Gwinnett Hospital System
- Health and Human Services Coalition
- Plan to phase out subsidies over several years, allowing the organizations to adapt
- Deficits
 - Eliminate existing deficit for 2010
 - Response to projected digest decline relating to commercial property values
- Parks
 - Reinstates recreation programs
 - Returns park maintenance
 - Opens recreation facilities as scheduled

What will not be funded by this increase? The approved increase will not restore cuts made within the County's internal support functions and also does not fund the Unified Plan, which was designed to better manage growth, public safety, quality of life, and economic development over the next several decades:

- Back office departments
- Board of Commissioners goals and initiatives
- Compensation plans (employee raises)
- Planned service enhancements
- 2030 Unified Plan

How does this affect the work of Engage Gwinnett? The Engage Gwinnett? The Engage Gwinnett Citizens Committee for the Future of Gwinnett will continue to study service levels and funding options in order to make recommendations to the Board of Commissioners in the first quarter of 2010.
